Sodium-2-pyridinethiol-1-oxide (S-002)

Your patch testing results indicate that you have a contact allergy to **Sodium-2-pyridinethiol-1-oxide**. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

What is **Sodium-2-pyridinethiol-1-oxide** and where is it found?

This chemical is used as a bactericide for use in cooling fluids, paints and some lubricants. It is also used as a preservative for cosmetic rinse-off products. Further research may identify additional product or industrial usages of this chemical.

What else is **Sodium-2-pyridinethiol-1-oxide** called?

This chemical can be identified by different names, including:

[3aR-(3aa,5b,8ab,9aa)]-3a,5,6,7,8,8a,9,9a-Octahydro-5, 8a-dimethyl-3-methylenenaphtho-[2,3-b]furan-2(3H)-one, 8b-hydroxy-4aH-eudesm-5-en-12-oic acid, Alant camphor, Elecampane camphor, Eupatal, Gamma-lactone, Helenin, Inula camphor, Sesquiterpene lactone.

THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

- **Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.
- **Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.
- **Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.
- **Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.
- **"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical.
