



## PATIENT INFORMATION SHEET

### Reactive Black 5

(R-004B)

Your patch testing results indicate that you have a contact allergy to **Reactive Black 5**. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

#### What is **Reactive Black 5** and where is it found?

This chemical is used as a dye for coloring cotton, wool, silk and polyamide textiles. Further research may identify additional product or industrial usages of this chemical.

#### What else is **Reactive Black 5** called?

This chemical can be identified by different names, including:

*tetrasodium salt, Levafix Black E-B, Colour index no 20505, Primazin Black BN, C.I. REACTIVE BLACK 5, Remazol Black GF, Black B, R/K 3B, Sumifix Black B, Black VS-B,*

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

### THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

- **Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.
  - **Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.
  - **Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.
  - **Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.
  - **"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical.
