

PATIENT INFORMATION SHEET TOCOPHEROL

(T-036)

Your patch testing results indicate that you have a contact allergy to TOCOPHEROL. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

What is TOCOPHEROL and where is it found?

This chemical is used mainly as an antioxidant in pharmaceutical, cosmetic and food formulations. It is found in many personal care products such as skin creams, moisturizers, medicated lotions, skin and eye cosmetics, hair care and hair styling products, baby wipes, lip balms and cold sore products, shaving creams, soap & cleansers, sunscreens, and antifungal products. Further research may identify additional product or industrial usages of this chemical.

What else is TOCOPHEROL called?

This chemical can be identified by different names, including: 2H 1 Benzopyran 6 ol., DL-alpha-Tocopheryl acetate, 3,4 dihydro 2,5,7,8 tetramethyl 2 (4,8,12 trimethyltridecyl) DL-alphatocopherol All-rac-alpha-Tocopheryl acetate, Ephynal, Alpha-Tocopherol acetate, Syntopherol acetate, CCRIS 6054, Vitamin E acetate dl-form, DL-alpha-Tocopherol acetate

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

Be vigilant... read the product label. Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

Test the product first. If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

Advise people you obtain services from of your contact allergy. This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

Inform your employer if the source of your contact allergy is work related. You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.
