

## PATIENT INFORMATION SHEET

### "Deleted" METHYLPARABEN

(M-012)

Your patch testing results indicate that you have a contact allergy to "Deleted" METHYLPARABEN. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

#### What is "Deleted" METHYLPARABEN and where is it found?

This chemical is used as a preservative in foods (salad dressings, mayonnaise, spiced sauces, mustard, frozen dairy products, baked products), cosmetics and pharmaceutical preparations. Further research may identify additional product or industrial usages of this chemical.

#### What else is "Deleted" METHYLPARABEN called?

This chemical can be identified by different names, including:

*4-Hydroxy methyl benzoate, 4-Hydroxybenzoic acid methyl ester Aseptiform, Methylparaben, Methyl Chemosept, Methyl Parasept, Methyl-4-hydroxybenzoate, Nipagin, Nipagin M, Tegosept M*

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

## THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

**Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

**Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

**Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

**Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.

**"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical.
