

## PATIENT INFORMATION SHEET

### Fragrance mix I

(Mx-07)

Your patch testing results indicate that you have a contact allergy to **Fragrance mix I**. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

#### What is **Fragrance mix I** and where is it found?

Fragrances can be found in most products, especially cosmetics, as they are used to add scent or flavor. Fragrance Mix contains cinnamic alcohol, cinnamic aldehyde, hydroxycitronellal, amylcinnamaldehyde, geraniol, eugenol, isoeugenol, and oakmosse absolute; chemicals which are commonly used in cosmetics, laundry detergents, fabric softeners, air fresheners, toothpastes, perfumes and other personal hygiene products. Further research may identify additional product or industrial usages of this chemical.

#### What else is **Fragrance mix I** called?

This chemical can be identified by different names, including:

*Amylcinnamaldehyde, Geranyl Alcohol, Cassia Aldehyde, Hydroxycitronellal, Cinnamic Alcohol, Isoeugenol, Cinnamic Aldehyde, Jasmine Aldehyde, Eugenol, Muguet Synthetic, Geraniol, Oakmosse Absolute*

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

## THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

**Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

**Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

**Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

**Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.

**"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical. Some helpful independent internet links
