

## PATIENT INFORMATION SHEET Dimethyl fumarate (D-066B)

Your patch testing results indicate that you have a contact allergy to Dimethyl fumarate. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

## What is Dimethyl fumarate and where is it found?

Dimethyl fumarate (DMF) is a chemical compound that is derived from the base compound fumaric acid. DMF is a biocide that prevents moulds that may deteriorate leather furniture, clothing or footwear during storage or in transport in humid climate. DMF penetrates through patient's clothes, onto the skin, where it can cause skin contact dermatitis. (It can sometimes be found in little pouches inside of furniture or added to footwear boxes.) Further research may identify additional product or industrial usages of this chemical.

## What else is Dimethyl fumarate called?

This chemical can be identified by different names, including: Dimethyl (E)-butenedioate, trans-1,2-ethylenedicarboxylic acid dimethyl ester, (E)-2-Butenedioic acid dimethyl ester, (2)-2) butenedioic acid dimethyl ester, Allered is acid dimethyl ester acid dimethyl ester, (E)-2-Butenedioic acid dimethyl ester,

(2E)-2-buenedioic acid dimethyl ester, Allomaleic acid dimethyl ester, Boletic acid dimethyl ester, Dimethyl transethylenedicarboxylate, Methyl fumarate, Trans-Butenedioic acid dimethyl ester, Related diesters include: Diethyl fumarate, dimethyl maleate, dimethyl malonate, dimethyl adipate.

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

## THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

**Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

**Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

Advise people you obtain services from of your contact allergy. This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

**Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.

**"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical. Some helpful independent internet links
